
A SWEET NEW YEAR






EXPENSES BY CATEGORY




REVENUE BY SERVICE LINE

UNCOMPENSATED CARE

In 2022, uncompensated care totaled \$2.36M, bridging the gap between what it costs to provide the highest quality programs and services, and what we receive through Medicaid.

Health care reimbursements remain flat, as care becomes more costly for a senior population projected to grow dramatically over the next 15 years. Kline Galland's guarantee in providing exceptional care to every senior in our

continuum is made possible because of donors. Regardless of the size of your bequest, your contribution will make a significant difference in bringing the priceless gifts of care, respect, and spiritual nurturing to our elderly.
