



UNCOMPENSATED CARE

In 2023, nearly \$1.2 million in uncompensated care was required to bridge the gap between the cost of providing the highest standard of care and Medicaid's significant contribution, which covers 93% of the costs.

Healthcare reimbursements have plateaued even as the expenses of senior care continue to rise, especially given the significant increase in the elderly population anticipated over the next fifteen years.

Kline Galland's commitment to delivering exceptional care to every senior within our continuum is upheld through the generosity of donors. No matter the size of your donation, your investment plays a vital role in delivering the care, dignity and spiritual support our community expects when they receive care from Kline Galland.
